4. **Copy:** Reflects how clearly and appropriately your writing communicates the message.
5. **Design:** Reflects the visual appeal of your slides
6. **Rigor:** Reflects the overall completeness and investor readiness of the deck, showing how well the pieces work together to build a case.
7. **Final Overall Score:** An average of all six scores.
